THE COMPANIES ACT, 2013 (NO. 18 OF 2013) MEMORANDUM OF ASSOCIATION OF

## HERANBA INDUSTRIES LIMITED (Incorporated under Companies Act, 1956)

#### Company Limited by Shares Indian Non-Government Company Having share capital

- I. The Name of the Company is: **HERANBA INDUSTRIES LIMITED.**
- II. The Registered Office of the Company will be situated in the **STATE OF GUJRAT.**

## III. (A) THE OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:—

1. To carry on business as manufacturers, formulators, processors, producers makers, buyers, sellers, resellers, importers, exporters, distributors, suppliers, fermentators, distillers, refiners, stockists, agents, merchants of and dealers in chemicals, chemical compounds (organic and inorganic) in all forms (solid, liquid and gaseous) and of all kinds, heavy chemicals, acids, alkalies, tannin extracts solvents, dyestuffs, dyes, intermediates, colours, chemical auxillariers, bio chemicals and its related preparations, articles and products.

## (B) MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE III (A) ARE:—

- To acquire real or leasehold estate and to purchase, lease or otherwise acquire or
  provide many place in which any part of the business of the company may from time
  to time be carried on, all such offices, warehouses, workshops, buildings, houses for
  employees and Directors, Machineries, Engines, plant and appliances as may be
  considered requisite for the purpose of carrying on the business of the company or
  any part thereof.
- 2. To form, constitute, float, lend money to assist and control similar associations or undertakings whatsoever.
- 3. To promote subsidies and assist companies, syndicates and partnerships of all kind in any manner as may be thought fit in connection with any or the above objects of the company.
- 4. To hold use, work, manage, improve, carry on, develop the undertaking, lands and movable estate or property and assets of any kind of the company or any part thereof.

Originally the Company was incorporated as Private Limited as on 17-03-1992, was Converted Into Public Limited company and Changed its name From "Heranba Industrial Chemicals Private Limited" To "Heranba Industries Limited" W.e.f. 26-07-1996

- 5. To dispose of any property of the company either absolutely or conditionally and in such manner and upon such terms and conditions in all respects as may be thoughts fit and to accept payments or satisfaction for the same in cash or otherwise.
- 6. To subscribe for, take or otherwise acquire and hold shares, stocks debentures or other securities of any other company having objects altogether or in part similar to those of the company or carrying on any business capable of being conducts so as directly to benefit of the company.
- 7. To subscribe on contribute or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific, national, public, or any other useful institutions in their object or purposes or for any exhibitions but not for political objects.
- 8. To establish and maintain or procure the establishment and maintenance of any contributory or non-contributory pension or superannuation funds for the benefit of and give or procure the giving of donation gratuities pensions, allowances or emoluments to any persons who are or were at any time in the employment or service to company or of any company which is a subsidiary of the company or is allied to or associated with the company or with any such subsidiary company or who are/were at any time directors or officers of the company or of any such other company as aforesaid and the wives, widows, families and dependents of any such persons and also to establish and subsidies and subscribe to any institutions, association, club or funds calculated to be for the benefit of or to advance be interest well-being of the company or of any such other company as aforesaid and make payment to or towards the insurance of any such persons as aforesaid and to any matters aforesaid either alone or in conjunction with any other company as aforesaid.
- 9. To provide for the welfare of Directors, employees, or ex- employees of the Company and the wives, widows and families of the dependents or connections of such persons by building or contributing for the building, houses, dwelling or quarters, or by grants of money, pensions, gratuities, allowance, bonus, profit sharing bonus or benefits or other payments or by creating and from time to time subscribing or contributing to provident and other associations, institutions, funds profit sharing or other scheme or trust and by providing or subscribing, or contributing towards places of instruction and recreation, hospitals and dispensaries medical and other assistance as the Company shall think fit.
- 10. To establish, provide, maintain and conduct or otherwise subsidies research, laboratories and experimental workshop for scientific and technical research experiments and under-take and carry on with all scientific and technical research experiments and tests of all kinds and to promote studies and research both scientific and technical investigation and invention by providing subsiding or assisting laboratories workshop, libraries, lectures, meeting and conferences and by providing the remunerations of scientific of technical professor or teacher and by providing for the awards or exhibition, scholarship prizes and grants to students or otherwise and generally to encourage promote and reward studies researches, investigation, experiment, tests and invention of any kind that may be considered likely to assist any of the business which the Company is authorised to carry on.
- 11. To appoint any Directors or Managers of any subsidiary company or of any other company in which this Company is or may be interested.

- 12. To aid pecuniary or otherwise, any association, body or movement having similar object, the solution, settlements or labour problems or the promotion of industry or trade.
- 13. To acquire and undertake all or any part of the business property and liabilities of any persons, company carrying on or proposing to carry on any business which the company is authorised to carry on or possessed of property suitable for the purpose of the Company which can be capable of being conducted so as directly to benefit the Company and to subsidies or assist any such persons or company financially or otherwise.
- 14. To vest any moveable or immovable property rights or interests acquired by or belonging to the Company in any person or Company on behalf of or for the benefit of the Company and with or without any declared trust in favour of the Company.
- 15. To lend and advance money or give credit to such persons or companies and on such terms as may seem expedient and in particulars to customers and other having dealing with Company and guarantee the performance of any contract or obligation and the payments of money to any such persons or companies and generally to give guarantee and indemnities.
- 16. To guarantee the payment of money secured or unsecured by or payable under in respect of promissory notes, bonds, debentures, debenture-stock, contracts, mortgage charges, obligations, instruments of any person whatsoever, whether incorporated or not and generally to guarantee or become securities for the performance of any contracts or obligations.
- 17. To undertake and execute any trust, the undertaking of which may seem to the Company desirable either gratuitously or otherwise.
- 18. To carry on business or branch of a business which this Company is authorised to carry on by means or through the agency of any subsidiary or other companies and to enter in to any agreement with such subsidiary Company for taking the profits and bearing the loss at any business or branch so carried on, or for financing any such business or branch so guaranteeing its liabilities or to make any other arrangements which may seem desirable with reference to any business or branch so carried on including power at any time and either temporarily to close any such branch or business.
- 19. To pay all preliminary expenses of any company promoted by the Company or any company in which this Company is or may contemplate being interested including in such preliminary expenses all or any part of the cost and expenses of owners of any business or property acquired by the Company.
- 20. To procure the incorporation, registration or other recognisation of the Company in any country, state or place outside India and to establish maintain local registers and branch places of business in any part of the world subject to law in force.

- 21. To create any depreciation fund, reserve fund, sinking fund, insurance fund, educational fund or any other special fund or reserves whether for depreciation or for repairing improving, extending or maintaining any of the properties of the Company or for redemption of debentures or redeemable preference shares or for any other purposes conducive to the interest of the company.
- 22. Subject to the provisions of the Companies Act, 1956 to place to reserve or to distribute as dividends or bonus share among the members or otherwise to apply any money received by way of premium on shares or debentures issued at a premium by the Company and any money received in respect of dividends accrued on or arising from the sale of forfeited shares.
- 23. To establish, promote or concur in establishing or promoting and company or companies for the purpose of acquiring all or any of the properties, rights and liabilities of the Company or for any other purpose which may seem directly or indirectly, calculated to benefit the company and to place or guarantee the placing of subscribed for or otherwise acquired all or any part of the shares, business capable of being conducted so as directly or indirectly to benefit the Company.
- 24. To payout of the funds of the company all costs, charges and expenses of and incidental to the promotion, formation, registration and establishment of the Company and the issue of its capital including any undertaking or other commissions, broker's fees and charges in connection therewith and to remunerate (by cash or other assets or by the allotment of fully or partly paid up shares) or by a cell or option on shares, debentures, debenture-stocks, or securities of this or any other or in any other manner whether out of the company's capital or profits or otherwise to any person or persons for services rendered in introducing any property or business to the company, in placing or assisting to place or guaranteeing the subscription of any shares, debentures, debenture-stock or other securities of the Company as the directors may think proper.
- 25. To draw, make, accept, endorse, discount, execute, issue, negotiate, assign and otherwise deal with cheques, drafts, bills of exchange, promissory notes, hundies, debenture, bounds, bills of landing, railway receipts, warrants and all other securities of the Company as the directors may think proper.
- 26. To insure with any other company or persons against losses, damages, risks and liabilities of all kinds ,this may affect this Company.
- 27. To open account or accounts with any firm or Company or with any bank of banks or bankers or shroffs to pay into, withdraw money from such account or accounts.
- 28. To apply for, tender, purchase or otherwise acquire and contracts, sub-contracts, licences and concessions for or in relation to the objects or business herein mentioned or any of them and to undertake execute, carry out dispose of or otherwise turn to account the same.
- 29. To employ experts to investigate and examine into the conditions, prospects, value, character and circumstances of any business concerns and undertakings having similar objects and generally of any assets, property or rights.

- 30. To take part in the management, supervision and control of the business or operation of any company or undertaking having similar objects and for that purpose to appoint and remunerate any directors, trustees, accounts or other experts.
- 31. Subject to the provisions of the Act, to pay for any properties, rights or privileges acquired by the Company either in shares of the Company or partly in shares and partly in cash or otherwise.
- 32. To amalgamate, enter into partnership or into any arrangement for sharing or pooling of profits, amalgamation, union of interest, cooperation, joint venture, reciprocal concession or otherwise with any person, firm or company carrying on or engaged in or about to carry on any business or transaction which may seem capable of being carried on or conducted so as, directly or indirectly to benefit the company.
- 33. To lend invest or otherwise employ or deal with money belonging to or entrusted to the Company insecurities and shares or other movable or immovable property or without security upon such terms and in such manner as may be thought proper from time to time, to vary such transactions and investment in such manner as the Directors may think fit subject to the provisions of the Companies Act, 2013.
- 34. To purchase or otherwise acquire, protect, prolong and renew any patents, right, inventions, licences, protections and concessions which may appear likely to be advantageous or useful to the Company and to use and turn to account the same and to grant licence or privileges in respect of the same.
- 35. To pay or satisfy the consideration for any property, right, shares, securities or assets whatsoever which the company is authorised to purchase, or otherwise acquire either by payment in cash or by the issue of shares, or other securities of the Company, or in such other manner as the Company may agree to partly in one mode and partly in another.
- 36. To search for and to purchase, protect, prolong, renew or otherwise acquire from any Government, state or authority any patents, protections, licences, concessions, grants, decrees, rights, powers and privileges whatsoever which may seem to the Company capable of being turned to account, to work develop, carry out, exercise and turn to account the same.
- 37. To furtherance of the aforesaid objects of the Company,
  - (a) To enter into negotiations with and enter into arrangements and contracts and conclude the same with foreign and/or Indian parties and other persons for obtaining by grant, licence, and/or on other terms, formulate and other right and benefits, and to obtain technical and engineering information assistance and service know how and expert advice for installation of plant and machinery, production and manufacture of any products, and
  - (b) To pay for technical know-how, technical and engineering assistance and information and/or service rights or privileges acquired by the Company either in shares of the Company or partly in cash or otherwise.

- (c) To pay to promoters such remuneration and fees and otherwise recompense them for their time and for the service rendered by them.
- 38. To do above things as may be incidental or conducive to the attainment of above objects, as principals and as or through agents, brokers, trustees, contractors, either alone or in partnership or in conjunction with others.
- 39. Subject to the provisions of Section 73 & Section 74 of the Companies Act, 2013 and the Rules made thereunder and the directives of the Reserve Bank of India, to borrow or raise or secure the payments of money or to receive money on deposit at interest for any of the purposes of the Company and such time and from time to time and in such manner as may be thought fit and in particular by the issue of debenture or debenture- stocks convertible into shares of this or any other company or perpetual annuities and as security for any such money so borrowed, raised or received or for any such debentures or debenture-stocks so issued to mortgage, pledge or charge the whole or any part of the property, assets, or revenue and profit of the Company present or future including its uncalled capital by special assignments or otherwise or to transfer or convey the same absolutely or in trust and to give the lenders powers of sale and other powers as may expedient and to purchase, redeem or payoff any such securities and also by a similar mortgage, change or line to secure and guarantee the performance by the Company or any other person or company as the case may be provided that the Company shall not carry on banking business as defined in the Banking Regulation Act, 1949.
- 40. To enter into any agreements and to take all necessary or proper steps with Governments or with other authorities imperial, supreme, national, local, municipal or otherwise of any place in which the Company may have.
- 41. To apply for, promote, and obtain any Act of Parliament or Legislature, charter, privilege, concession, licence or authorisation of Government State or Municipality provisional order or licence of the Board of Trade or other authority for enabling the Company to carry out any of the objects into effect or for extending any of the powers of the Company of for effecting any modification of the constitution of the Company for any other purpose which may seem calculated, directly or indirectly to prejudice the interests of the Company.
- 42. To make and/or receive donations, gifts or income to or from such persons, institution or trusts and in such cases and whether of cash or any other assets as may be thought directly or indirectly to benefit the Company or any of the objects of the Company and also to remunerate any person or corporation introducing or assisting in any manner the business of the Company.
- 43. To establish and support or aid in the establishment of and support associations, institutions, companies, societies, funds, trusts and convinces for the benefit of the employees or ex-employees or of persons having dealing with the Company or the dependents, relatives or connections of such persons and in particular friendly or other benefit societies and to grant pensions, allowances and bonuses either by way of annual payments or by way of lump-sum and to make payments towards insurance and to form and contribute to provident and benefit funds, or to such persons.
- 44. To indemnify members, officers, directors, agents and employees of the Company against proceedings, cost, damages, claims and demands in the interest of the Company or any loss, damage or misfortune whatsoever which shall happen in the execution of the duties of their offices or in relation thereto.

- 45. To establish agencies in India and elsewhere for sale and purchase to regulate and discontinue the same subject to law in force.
- 46. Subject to the provisions of the Act, the Company shall have power to borrow any sum or sums of money for the purpose of the company on such terms and conditions and from such person or persons, forms, bank or any financial, industrial, institutions or any government or semi-government corporation as the company may deem fit.
- **IV.** The liability of the member(s) is limited and this liability is limited to the amount unpaid, if any, on the shares held by them.
- V. The Authorized Share Capital of the company is Rs. 45,00,00,000/- (Rupees Forty Five Crore Only) divided into 4,50,00,000 (Four Crore Fifty Lakh) Equity Shares of Rs. 10/- (Rupees Ten only) each with power to increase, modify and reduce the Capital of the Company and to divide the shares in the capital for the time being into several classes and to attach thereto respectively such preferential, deferred, qualified, or special rights, privileges or conditions as may determined under the provisions of the Companies Act 2013 or any other applicable Act(s), Rule(s) and Regulation(s).
